**1. Attendance and voting at Meetings**

It was established that a Quorum was present under either the constitution definition or as minuted at last meeting. For reference - an amendment is required for clarification at the AGM in December.

- *Constitution Definition :*  
*The club will be managed through the Management Committee consisting of the officers (6 roles currently filled by 5 members)*  
*All members will have the right to vote at meetings of the Management Committee*  
*The quorum required for business to be agreed at a Management Committee meeting must be at least 25% of the membership or 6 members, whichever is the greater.*
- *Minutes from June : It has been deemed that for voting on motions a quorum of half the PGS must be in attendance at a meeting for a motion to be carried. (7)*

**2. Communication**

- WhatsApp continues with friendly banter and etiquette observance (mostly)
- The MOE tally will be continued by Mr Bickford until the end of August and will then change monthly.

**3. Officers Reports and Actions**

In the agreed absence of Mr Foster and Mr Turner, the minutes from previous meetings were reviewed and actions to be highlighted for them to pursue accordingly.

**3.1. Secretary**

- Mr Hawkins agreed to produce minutes for this meeting.

**3.2. Sales Officer**

- It was agreed that Dickie Bows were to be sourced immediately with the following guidelines to be followed by the Sales Officer
  - All bow ties for members to be identical.
  - Several ideas for designs to be circulated for indication of preferences with a guide price of £15.
  - Agreed to source designs based on the Penkridge colours of blue and yellow – probably with stripes. See logos of Penkridge clubs at end of minutes
  - Agreed to get bow ties agreed, sourced and procured by the next meeting on 11<sup>th</sup> October.
  - Mr Turner to confirm that the bow ties with coins logo on were £72 each ?!
- Waistcoats to be sourced in 2018 and Jackets 2019 – to be agreed later
- Mr Hawkins to investigate the possibility of a Polo shirt (max £10) with PGS logo as per the recent JAK 60 Golf T Shirt.

**3.3. Treasurer**

- Mr Adams has arranged a meeting at 10am at Nationwide on Saturday 19<sup>th</sup> August to open a club bank account. Mr Harrison Snr also to attend.
- Subscriptions of £20 for 2017 to be paid by members by the next meeting on 11<sup>th</sup> October – online payment details to be circulated to members when available.
- Costs already incurred by members to be reimbursed soon after the 11<sup>th</sup> October.

- Trophies have been returned from engraving and one was presented back to Mr Southan – Mr Adams to arrange the Champions Trophy to be passed to Mr Turner as soon as possible.
- The consideration for a wooden spoon trophy was debated and voted for by a majority vote.

Mr Adams to source a Trophy from his contact and get it engraved with the results from the 3 previous championships agreed as : 2014 (The Unknown Spoofers) 2015 (Mr W. Adams) 2016 (Mr N. Hawkins)
